
**THE GALBANI® ROCCBOX® SWEEPSTAKES OFFICIAL RULES (“OFFICIAL RULES”)
NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.**

1. **SWEEPSTAKES PERIOD:** The Galbani® Roccbox® Sweepstakes (“**Sweepstakes**”) begins at 12:00 a.m. Eastern Time (“**ET**”) on March 01, 2019 and ends at 11:59 p.m. ET on April 30, 2019 (the “**Sweepstakes Period**”).
2. **ELIGIBILITY:** The Sweepstakes is open only to Food Service Industry Professionals who are legal residents of the fifty (50) United States and the District of Columbia and are at least 18 years of age (or the age of majority in their jurisdiction of residence) as of the date of entry (“**Entrant**”).
